

Clean substrate using a soft cloth and BODY 770 ANTISIL NORMAL / BODY 771 ANTISIL FAST.

Make sure the surface is air dried rather than wiped dry

100:3 mix with **BODY HARDENER** Pot life: 4min / 23°C



Apply with the spatula

Cleaning of equipment: Clean after final use with Body 740 ACRYL NORMAL

Remarks:

 Application only with Body Hardener. Mix well with the putty. Do not add more than 3% as this may cause staining of the topcoat finish.

•Do not apply to Etch Primer, 1K Filler, TPA substrates and soft old paintwork.

• Do not apply at temperatures below +5 °C

• It can be used by countries that do not adopt the VOC legislation as well.

Storage shelf life:

 Polyester materials have a limited shelf life. Store in a cool place and use within 12 months for best results.Guaranteed shelf life of 24 months in unused original containers.
